

## Searchlight "A Complete Unknown" Sweepstakes Rules

**Eligibility:** NO PURCHASE OR CONTRIBUTION NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR CONTRIBUTION WILL NOT IMPROVE AN INDIVIDUAL'S CHANCE OF WINNING. The Sweepstakes (the "**Sweepstakes**") is open to all legal U.S. residents (except residents of FL, NY and RI,) who are at least twenty-one (21) years of age, except employees, directors and officers (or any persons who have been employees, directors or officers in the past twelve months) of KCRW Foundation ("**Sponsor**"), Santa Monica College, or prize suppliers and their affiliates, partners, subsidiaries, franchises, distributors, retailers, advertising and promotion agencies ("**Sponsor Parties**"), and the immediate families or household members of each. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited or restricted by law or regulations.

**How to enter:** The Sweepstakes begins at 12:01 a.m. PT on December 1, 2024, and ends at 11:59 p.m. PT on December 7, 2024 ("**Sweepstakes Period**"). Any eligible individual who donates \$25 or more to KCRW during the Sweepstakes Period will automatically be entered into the Sweepstakes drawing corresponding to the day the donation is made. All current monthly members are automatically entered. Purchase does not increase the chances of winning. To enter without a donation, submit your full name, email address, complete address with zip code, date of birth, and phone number with area code at [kcrw.com/searchlight](https://kcrw.com/searchlight). The date and time of the email defines the drawing into which an emailed entry will be entered. Regardless of the method of entry, only one (1) entry per person/per household per day will be allowed. Duplicate entries for the same day will be disqualified. All entries become the property of Sponsor and will not be acknowledged or returned.

**Prizes:** Odds of winning depend on the number of eligible entries received. One (1) winner will receive the following prize ("**Prize**") (ARV: \$3,125):

- One private screening of "A Complete Unknown" at The Culver Theater for the winner and 24 guests
- \$25 gift cards in concessions for 25 people
