

Fall 2024 Flash Sweepstakes Rules

Eligibility: NO PURCHASE OR CONTRIBUTION NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR CONTRIBUTION WILL NOT IMPROVE AN INDIVIDUAL'S CHANCE OF WINNING. The Spring 2024 Flash Sweepstakes (the “**Sweepstakes**”) is open to all legal U.S. residents (except residents of FL, NY and RI,) who are at least twenty-one (21) years of age, except employees, directors and officers (or any persons who have been employees, directors or officers in the past twelve months) of KCRW Foundation (“**Sponsor**”), Santa Monica College, or prize suppliers and their affiliates, partners, subsidiaries, franchises, distributors, retailers, advertising and promotion agencies (“**Sponsor Parties**”), and the immediate families or household members of each. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited or restricted by law or regulations.

How to enter: The Sweepstakes begins at 12:00 am PT on September 12, 2024, and ends at 11:59 pm PT on September 23, 2024 (“**Sweepstakes Period**”) and comprises a series of separate daily entry/drawing periods as defined in the “Selection of Winners” rule below. Any eligible individual who contributes \$25 or more to KCRW during the Sweepstakes Period will automatically be entered into the Sweepstakes drawing corresponding to the day the donation is made. Donation does not increase the chances of winning. To enter without contributing, submit your full name, email address, complete address with zip code, date of birth, and phone number with area code at kcrw.com/flashsweeps. The date and time of the email defines the drawing into which an emailed entry will be entered. Regardless of the method of entry, only one (1) entry per person/per household per day will be allowed. Duplicate entries for the same day will be disqualified. All entries become the property of Sponsor and will not be acknowledged or returned.

Prizes: One (1) prize is available per Sweepstakes Period. Odds of winning depend on the number of eligible entries received during Sweepstakes Period.

Day #1-7:

The sweepstakes starts 12:00 am PT on September 12, 2024 and ends at 2:00 pm PT on September 18, 2024.

Prize: One (1) winner will receive two (2) VIP tickets to Ritvales Festival 2024, hotel accommodations for two (2), a \$1,000 airline gift card, and ground transportation for two (2) to and from the festival each day. (ARV \$2,240)

Day #9:

The sweepstakes starts 12:00 am PT on September 20, 2024 and ends at 11:59 pm PT on September 20, 2024.

Prize: One (1) winner will receive a (4) person box at the Hollywood Bowl to see Mitski & Sharon Van Etten on Saturday, September 28 at 8:00 pm PT. (ARV \$1,000)

Day #12:

The sweepstakes starts 12:00 a.m. PT on September 23, 2024 and ends at 11:59 p.m. PT on September 23, 2024.

Prize: One (1) \$900 Apple gift card to purchase the new iPhone 16 (ARV \$900).

Day #14:

The sweepstakes starts 12:00 a.m. PT on September 25, 2024 and ends at 11:59 p.m. PT on September 25, 2024.

Prize: Four (4) tickets to KCRW's Masquerade on Friday, October 25. (ARV \$400).

Prize consists of only those items specifically listed as part of the prize. Sponsor reserves the right to substitute a Prize of equal or greater value.

Winner will be responsible for all expenses (including not limited to, travel and expenses) not specifically included herein, and all applicable federal, state and local taxes. Selection of winner: One (1) winner for each Sweepstakes Period will be determined in a random drawing on or about three (3) days from the drawing (from among all eligible entries conduct.)
