

Spring 2025 Flash Sweepstakes Rules

Eligibility: NO PURCHASE OR CONTRIBUTION NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR CONTRIBUTION WILL NOT IMPROVE AN INDIVIDUAL'S CHANCE OF WINNING. The Spring 2025 Flash Sweepstakes (the “**Sweepstakes**”) is open to all legal U.S. residents (except residents of FL, NY and RI,) who are at least twenty-one (21) years of age, except employees, directors and officers (or any persons who have been employees, directors or officers in the past twelve months) of KCRW Foundation (“**Sponsor**”), Santa Monica College, or prize suppliers and their affiliates, partners, subsidiaries, franchises, distributors, retailers, advertising and promotion agencies (“**Sponsor Parties**”), and the immediate families or household members of each. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited or restricted by law or regulations.

How to enter: The Sweepstakes begins at 12:00 am PT on May 6, 2025, and ends at 11:59 pm PT on May 21, 2025 (“**Sweepstakes Period**”) and comprises a series of separate daily entry/drawing periods as defined in the “Selection of Winners” rule below. Any eligible individual who contributes \$25 or more to KCRW during the Sweepstakes Period will automatically be entered into the Sweepstakes drawing corresponding to the day the donation is made. Donation does not increase the chances of winning. To enter without contributing, submit your full name, email address, complete address with zip code, date of birth, and phone number with area code at kcrw.com/flashsweeps. The date and time of the email defines the drawing into which an emailed entry will be entered. Regardless of the method of entry, only one (1) entry per person/per household per day will be allowed. Duplicate entries for the same day will be disqualified. All entries become the property of Sponsor and will not be acknowledged or returned.

Day #7-8:

The sweepstakes starts 12:00 a.m. PT on May 15, 2025 and ends at 11:59 p.m. PT on May 16, 2025. Prize: One (1) winner will get to select a handpicked bundle of up to 10 Blue Note Records' legendary catalog and will receive a Alva ST turntable. (ARV \$999).

Day #9-10:

The sweepstakes starts 12:00 a.m. PT on May 17, 2025 and ends at 11:59 p.m. PT on May 18, 2025.

Prize: One (1) winner will receive Jazz Is Dead Series 2, tote, t-shirt, slipmat, and a pair of tickets to an upcoming Jazz is Dead concert (must be redeemed by April 2026). (ARV \$525).

Day #11:

The sweepstakes starts 12:00 a.m. PT on May 20, 2025 and ends at 11:59 p.m. PT on May 20, 2026.

Prize: One (1) \$900 Apple gift card to purchase the new iPhone 16 (ARV \$900).

Day #12

The sweepstakes starts 12:00 a.m. PT on May 21, 2025 and ends at 12:00 p.m. PT on May 21, 2025.

Prize: One (1) winner will receive a (4) person box at the Hollywood Bowl to see LCD Soundsystem and Pulp on 9/25/25 (ARV \$804).

Prize consists of only those items specifically listed as part of the prize. Sponsor reserves the right to substitute a Prize of equal or greater value.
