

Spring 2024 Flash Sweepstakes Rules

Eligibility: NO PURCHASE OR CONTRIBUTION NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR CONTRIBUTION WILL NOT IMPROVE AN INDIVIDUAL'S CHANCE OF WINNING. The Spring 2024 Flash Sweepstakes (the “**Sweepstakes**”) is open to all legal U.S. residents (except residents of FL, NY and RI,) who are at least twenty-one (21) years of age, except employees, directors and officers (or any persons who have been employees, directors or officers in the past twelve months) of KCRW Foundation (“**Sponsor**”), Santa Monica College, or prize suppliers and their affiliates, partners, subsidiaries, franchises, distributors, retailers, advertising and promotion agencies (“**Sponsor Parties**”), and the immediate families or household members of each. How to enter: The Sweepstakes begins at 12:00 am PT on May 13, 2024, and ends at 11:59 pm PT on May 22, 2024 (“**Sweepstakes Period**”) and comprises a series of separate daily entry/drawing periods as defined in the “Selection of Winners” rule below. Any eligible individual who contributes \$25 or more to KCRW during the Sweepstakes Period will automatically be entered into the Sweepstakes drawing corresponding to the day the donation is made. Donation does not increase the chances of winning. To enter without contributing, submit your full name, email address, complete address with zip code, date of birth, and phone number with area code at kcrw.com/flashsweeps. The date and time of the email defines the drawing into which an emailed entry will be entered. Regardless of the method of entry, only one (1) entry per person/per household per day will be allowed. Duplicate entries for the same day will be disqualified. All entries become the property of Sponsor and will not be acknowledged or returned.

Day #2-3:

Prize: Four (4) North End Terrace Seats to Saturday, July 6, 2024 Angel City FC match vs. NJ/NY Gotham FC & Four (4) ACFC 2024 Jerseys. (ARV \$900)

Day #5:

The sweepstakes starts 12:00 a.m. PT on May 17, 2024 and ends at 11:59 p.m. PT on May 17, 2024.

Prize: One (1) \$900 Apple gift card to purchase the new iPhone 15 (ARV \$900).

Day #8:

The sweepstakes starts 12:00 a.m. PT on May 20, 2024 and ends at 11:59 p.m. PT on May 20, 2024.

Prize: One (1) \$1,036 Disney gift card to purchase four (4) 1-Day Park Hopper Tickets to Disneyland (ARV \$676).

Day #10

The sweepstakes starts 12:00 a.m. PT on May 22, 2024 and ends at 12:00 p.m. PT on May 22, 2024.

Prize: One (1) winner will receive a (4) person box at the Hollywood Bowl to see Beck with the LA Phil on Saturday, July 6 at 8:00 pm PT (ARV \$1,000).

Prize consists of only those items specifically listed as part of the prize. Sponsor reserves the right to substitute a Prize of equal or greater value.
